AND DATA SOURCES**



## Glossary of Analyses, Terms, and Data Sources

### **Tables 1 & 2:**

**Birth rate:** The actual number of resident births recorded by Vital Statistics for the July 1, 2005 – June 30, 2006, fiscal year available for download as of October 2006. This number is a proxy for the number of screens a program may be able to conduct.

Birth rates reported here represent first births for all counties, except for the following: Crook, Gilliam and Harney. These counties were serving all births during 2005-6, so the birth rate is based on all births during that period. Jefferson County served all births for the first 7 months of the fiscal year, so their birth rate includes all births from July – January, and first births from February – June.

Vital statistics information is recorded for the mother only. Therefore it is possible that programs serving a high proportion of first time fathers may have a higher screening rate compared to their resident (mothers') births.

**Screening Rate:** For a family to be included in the screening rate, programs must (1) submit the NBQ to the evaluation team in time to be included in the analyses (by October 15, 2006 for screens dated July 2005 through June 2006), or (2) have a screening date entered into the OCCF Family Manager data system by October 18, 2006, or (3) have submitted end of the year additional contacts indicating screens performed on families not wishing to share their information with the evaluation.

**Rate of Declines:** Information on families declining Healthy Start information is collected by programs and submitted annually to the evaluation by the program managers.

### **Table 3:**

**Time to Screen:** The data for calculating “Time to Screen” comes from counting the number of days between the date of birth and the date of screen. These variables are taken from the NBQ. In the event the NBQ has not yet been submitted to the evaluation, the dates are taken from Family Manager. Prenatal screens are counted as zero days.

### **Table 4:**

During the 2005-06 Fiscal Year, a high-risk screen was defined as 1 or more risk factors on the NBQ. NBQs are typically completed either by the parent or by Healthy Start staff. A Spanish language version of the NBQ is available for those families preferring to read in that language.

These risk factors include:

- Being a teen mom (age 17 or younger) (Item 6b)
- Being single (Item 12)
- Having prenatal care more than 12 weeks into pregnancy or not at all (Item 13a)
- Having less than 5 health care visits while pregnant (Item 13b)
- Having less than a high school diploma or GED (Item 14)

- Both mother and spouse/partner (if present) being unemployed (Items 15 and 16)
- Reporting difficulty paying for living expenses some/most of the time (Item 17)
- Having a recent period (2+ weeks) feeling sad, hopeless or depressed (Item 18)
- Having some or serious problems with family relationships (Item 19)
- Feeling the need to cut down on drug/alcohol use (Item 20).

**Table 5:**

Information about mother's race/ethnicity is taken from Item 7 on the NBQ. Choices listed on the NBQ reflect any race/ethnicity in which there was at least 1% representation in any of Oregon's counties at the time the instrument was developed.

**Table 6:**

Language: Information on language spoken in the household is taken from Item 10 of the NBQ.

Teen Mothers: A teen mother is defined by Healthy Start as any mother who is age 17 or younger at the time of delivery. Mother's age is taken either from Item 6b on the NBQ (your current age) or is calculated by comparing Item 6a (mother's date of birth) to the date of the screen, to calculate mother's age at the time of screening.

Single Mothers: Marital status is determined by the answer to Item 12 on the NBQ.

Education Level: Determined by mother's response to Item 14 on the NBQ.

**Table 7:**

Health Insurance: Information about health insurance at the time of screening is taken from Items 11a (for mothers) and 11b (for baby) on the NBQ.

Prenatal Care: Information on prenatal care received is taken from Items 13a and 13b on the NBQ.

**Table 8:**

Risk factors reported are taken from responses to the following items on the NBQ:

- Parents' employment is calculated by looking at both responses to Item 15 and 16 on the NBQ. Both parents need to be unemployed in order for this Item to be counted as a risk factor.
- Trouble paying for basic living expenses is taken from responses to Item 17 on the NBQ.
- Symptoms of depression are taken from responses to Item 18 on the NBQ.
- Information on alcohol and drug use is taken from Item 20 on the NBQ.
- Information about relationship issues is taken from Item 19 on the NBQ.

**Table 9:**

Those families who have both a positive NBQ (at least 1 risk factor) and a “moderate” or higher score (25 or more out of 100) on the Kempe Inventory are counted as eligible for Intensive Service<sup>1</sup>.

Families offered and accepted service are identified during FY 2005-06 by program responses to Items A & B on the Kempe Inventory. Occasionally, a family originally declining service may decide later that they wish to receive service. Programs can serve these families based on program capacity, however individuals that fall into this scenario are not counted in the acceptance rate.

**Table 10:**

The duplicated count of Intensive Service families provides information about families who received service from multiple programs. This most often occurs when a family begins receiving service in one Healthy Start program, moves to another community in Oregon, and continues services with their new local Healthy Start program.

The duplicate count was determined by counting the mother in both the county of mom’s residence at the time of the NBQ, and the county indicated on the most recent evaluation form (i.e., Family Update) submitted to the evaluation team.

Newly Enrolled Intensive Service families includes all families who had a screening date during FY 2005-06, and for whom a Kempe form indicating the family accepted Intensive Service, and/or those families in which a Family Intake or other evaluation form was submitted

Families served with Creative Outreach only is a count of families who only received creative outreach during 2005-06. For these families, their last home visit occurred in 2004-05, however programs continued attempts (phone calls, letters, scheduling home visits) to engage those families in service in the current fiscal year.

The reports of families served with Creative Outreach only during the fiscal year of study is determined by comparing the Creative Outreach start and end dates (on the Exit Form) with the date of the last home visit (on the Exit Form).

**Table 11:**

Families accepting Intensive Service and receiving a first home visit is calculated by comparing the number of families who have Kempe forms indicating “Accepted Intensive Service” compared with the number of Family Intakes submitted. In the event a Family Intake was not submitted, but the family has other evaluation data indicating visits took place, the assumption was made that the family had a first home visit and is included in the analyses.

Information on families not receiving a first home visit is taken from reasons on the Exit Form. However, families coded with one of these reasons, but who had other evaluation data submitted suggesting they had received a first home visit, were counted as having received a first home visit.

New Intensive Service families receiving their first home visit prenatally or within 3 months of the birth of the baby is calculated by subtracting the date of the first home visit (from Item 2 on the Family Intake) from the baby's date of birth (taken from the NBQ or Family Manager, when appropriate).

Healthy Start program managers submit home visit information by Home Visitor to the evaluation team quarterly. The evaluation team compiles the rate of expected home visits using Healthy Families America standards that state that families should receive 75% or more of the expected visits, given their level of services. The percentage of families who meet these criteria is reported.

**Tables 12 - 15:**

Demographic information on Intensive Service families is taken from items reported on the NBQ (see Tables 5-8).

**Tables 16 & 17:**

Kempe risk factors are taken from Items 1-10 of the Kempe Inventory Form. Items on the Kempe form are rated by the worker as: 0 (not applicable) 5 (mild) or 10 (severe). Data reported here is the highest rating on a given item for either parent.

**Table 18:**

Families offered service are those whose Kempe form indicated a positive assessment (Item A) and were offered service (Item B, excluding (1) not offered, caseload full and (2) not offered, other). Families for whom Kempe data are missing but who received Intensive Services are not included.

Counts of accepted service are indicated on the Kempe form, Item B.

**Table 19:**

Demographics of families accepting Intensive Service (Item B on the Kempe form) are taken from the NBQ, for families who accept Intensive Service only (see Table 18)

**Table 20:**

Retention was calculated using the HFA recommended analysis strategy, which involves taking a sample of families enrolled during a given period in the past, and reporting on their retention in the program 3, 6, and 12 months later. For these analyses, families enrolled in FY 2004-05 were selected, as this provided adequate time to be able to look at a 12-month retention period. All families who were enrolled in Intensive Services (specifically, who received a first home visit or had a Family Intake form submitted during FY 2004-05 were included in the retention analysis. **However, families with an exit form indicating "moved" as an exit reason were not included in these analyses.**

**Tables 21 & 22:**

Demographic descriptions of “retained” families are based on responses to the NBQ from families enrolled during the 2004-05 fiscal year who remained in the program for 12 months or longer.

**Table 23:**

Average age at exit is determined by calculating the age of the child at the time of exit, using the birth date (from the NBQ) and the date of the last home visit (Exit Form).

Reasons for participants exiting the program are based on Healthy Start workers’ reports, as indicated on the Exit Form.

Other reasons include: parent in jail, child removed from custody, child deceased, concerns about FSW safety, and family transferred to another program. Programs were also given the option to describe reasons not listed on the exit form under “other.”

**Tables 24 - 26:**

Health care information comes from the most recently received Family Update.

- Parent’s primary health care provider information: Item 29
- Child’s primary health care provider information: Item 28
- Well-child check up information: Item 21
- Child’s health insurance information: Item 22
- Emergency room use: Item 23
- Immunization information: Item 20a

Analyses describing children lacking health insurance on the NBQ but having it at the most recent follow-up are determined by comparing Item 11b on the NBQ to Item 22 on the Family Update, for that group of children who had both pieces of information present.

Analyses describing the percentage of children immunized by age two examine the response to Item 20a on the Family Update only for those children who are 2 years of age (by comparing the child’s birth date to the date of the most recent Family Update form).

**Table 27:**

Comprehensive prenatal care for the initial and subsequent pregnancies is based on the mother receiving BOTH early (1<sup>st</sup> trimester) and comprehensive (5 or more check ups) prenatal care (Items 13a and 13b on the NBQ, and Item 31b on the Family Update).

Only mothers indicating they are currently pregnant with a subsequent pregnancy (on Item 31 of the Family Update), and who have information on subsequent prenatal care, are included in the analyses.

**Table 28 & 29:**

ASQ and ASQ-SE developmental assessments are administered by home visitors as early as 4 months of age, however the earliest the information is reported to the evaluation is on the 6 month Family Update. In order to be included in the “eligible for screening” data, children

had to be at least 6 months old, and therefore to be eligible to have a Family Update form completed.

If Family Updates indicated the child's development was being tracked by early intervention or that the child was receiving early intervention services, the family was given credit for having a screening even if there was no screening information on the Family Update. This is because home visitors are not required to do the developmental assessment if the child is receiving developmental services through Early Intervention.

The Home Visitor reports information on child's developmental status (normal, delays indicated, other) on the Family Update form (Items 36b and 37b).

Children with confirmed developmental delays are reported on the Family Update (Item 33).

Receipt of Early Intervention services (related to ASQ) is reported on the Family Update (Item 35).

Referrals/connections to other services (related to ASQ-SE) is reported on the Family Update (Item 37c)

**Table 30:**

Connecting the family to needed resources is taken from information reported by the home visitor on the 6-month Family Update (Item 11). Specifically, workers who indicated "Yes" on the question "Did anyone in the family lack the needed service since the Family Intake" have those families included in analyses. Families were included in the analysis if the worker indicated that they lacked the given service and if there was a response to the follow-up question, "Did you connect any family members to the needed service." Only families with responses to both parts of the question are included in the analyses.

**Table 31:**

Family outcomes and life events are taken from the most recent Family Update responses to Item 19.

**Table 32:**

Parenting skills and ability to help child learn are taken from Items 5 and 6 on the Parent Survey A. Data in this report is examined at 6 months and 12 months.

**Table 33:**

Measures of Parent-Child Interaction are obtained from parent self-report on the Parent Survey II, Part A. The activities described in Item 4 are examined for their frequency of "a few times a week", "about once a day" or "more than once a day".

HOME information is taken from workers' in-home observation of the home environment. Percentages for "good" or higher refer to families with total scores on the HOME reaching the 75<sup>th</sup> percentile or higher (above average) for the normative population as established by the tools and developers.

The home visitor reports information on families reading to their child 3 or more times a week on Item 42 of the HOME inventory.

**Table 34:**

Ratings of staff cultural competency are assessed by most recent parent responses (averaged) on the Parent Survey II, Part B, to the following items:

- Item 7b: Program staff encourage me to learn about my culture
- Item 7e: Program staff respect my family's cultural and/or religious beliefs
- Item 7g: Program staff have materials for my child that positively reflect our cultural background

Ratings of staff strengths orientation are assessed by most recent parent responses (averaged) on the Parent Survey II, Part B, to the following items, which ask about the extent to which Healthy Start has provided help.

- Item 7a: Help me to see strengths in myself I didn't know I had
- Item 7c: Help me to use my own skills and resources to solve problems
- Item 7d: Work together with me to meet my needs
- Item 7f: Help me to see that I am a good parent
- Item 7h: Encourage me to think about my own personal goals or dreams

**Table 35:**

Ratings of home visitor helpfulness are taken from the family's last completed Parent Survey II, Part B, on the following items:

- Item 6b: Need for basic household resources
- Item 6d: Develop positive relationships with family or friends
- Item 6c: Need for information on parenting and child growth/development
- Item 6f: Emotional issues: feeling depressed, overloaded with stress
- Item 6j: Need for education, job training or help with employment

Items are rated as 1= helped a lot, 2 = helped a little, 3 = hasn't helped. Percentages reflect the percent of families reporting, "helped a little" or "helped a lot."

**Table 36:**

Information on parent stress is taken from the Parenting Stress Index, on the Parent Survey, Part A. The following items are averaged, and the percentage of families whose scores increase vs. decrease from the first to the second Parent Survey are calculated.

- Item 7e: I find myself giving more of my life to meet my child's needs than I ever expected
- 7i: I feel trapped by my responsibilities as a parent
- 7k: Since having a baby, I am almost never able to do the things that I like to do
- 7p: Having a baby has caused more problems than I expected in my relationships

Income change information is obtained from the home visitor's most recent response to Item 10 on the Family Update for a family.
